03. DATE OF COMMENCEMENT OF TRUST:

a) The trust is deemed to have come into existence on this 23rd Day of January, 2013, the date of original formation of the trust, irrespective of the date of registration with Sub-Registrar, Income Tax authorities and any other departments / authorities.

b) The trust can commence its activities from this 23rd Day of January, 2013, even before getting registration with the authorities said in (a) above.

04. OBJECTS OF THE TRUST:

To utilise the original corpus and subsequent income of the said Trust Fund for public charitable purposes, i.e, education, relief of the poor, medical and social objects without discrimination of caste, creed, colour or sex and to particularly carryout the following activities in India.

A.MAIN OBJECTS:

To carry on the following objectives of education, relief to the poor, medical relief and the other objectives of general public utility without discrimination of caste, creed, color or sex within India without profit motive.

1) To establish, promote, set up, run, maintain, assist, finance, support and / or aid to or help in the setting up and /or maintaining and or running schools, colleges and other institutions, orphanages, widow homes, old age homes, homes for mentally retarded, lunatic asylums, poor houses or other establishments for relief and /or help to the poor, old and infirm people and /or destitute.

2) To run Educational Institutions such as Schools, Colleges, Polytechnics, ITI's etc., and this shall not be in the nature of conduction of business activity and also not with profit motive.


3) To give, provide and /or render help and assistance in cash or in kind to poor and /or destitute people, widows etc.

4) To give, provide and /or render help and assistance to and /or implement any scheme for providing livelihood and upliftment of poor.

5) To give, provide and or render food, medicine and or other help and /or assistance in any shape or form to the poor deserving and needy persons.

6) To give, provide and /or render monetary and /or other help and assistance for the relief of persons and animals affected by natural and other calamities such as flood, tsunami, fire, famine, cyclone, earthquake, storm, accident, pestilence, drought, epidemic, unbearable cost of living and the like, to give donations, subscriptions, or contributions to institutions, establishments, centres, or persons doing relief work on such occasions.

7) To start, maintain, assist any relief measures in those parts which are or become subjected to natural calamities such as flood, tsunami, fire, drought, famine, cyclone, earthquake, epidemic, storm, accident, pestilence, etc.

8) To establish, maintain, grant aid for the establishment or maintenance of wells, tube-wells, tanks, water-reservoirs, and trees and construction of and repairs to paths, roads, bridges, etc for the use of public.

9) To give, provide, distribute, dhotis, blankets, rugs, woolen clothing, quilts of cotton, woolen, silk, or other varieties of clothes, or other articles of necessity and facilities for the poor.


10) To open, found, establish, promote, set-up, run, maintain, assist, finance, support and /or aid or help in the setting up and / or maintaining and / or running schools, colleges, polytechnics, teacher training schools and colleges, nursing training institutions, engineering colleges, medical colleges, management schools, lecture halls, community halls and other establishments, or institutions for advancement of education and of knowledge in arts, science, engineering, literature, humanities, computer science, medicine, nursing and all other useful subjects in all their manifestations.


11) To promote, advance, and encourage and / or aid in helping, promoting, advancing and encouraging primary, secondary and higher education including technical, engineering and medical education and also physical training, training of handicrafts, fine arts and other useful arts, crafts among the public including any other income generation programmes.

12) To foster, and encourage education and training in handicrafts, fine arts, computer literacy among women folk in general and establish and found institutions imparting such education and to establish, maintain, support or help by monetary gifts, or otherwise, centres and institutions for women and children and to provide social welfare works for women and children.

13) To grant, pay or give scholarships, stipends, prizes, rewards, allowance, and other financial assistance or help in cash or kind to students with a view to help them in proceeding their sports, studies in schools, colleges, educational institutions, technical institutions, art schools, institutions, teaching commercial and other arts including teaching of computer subjects, cultural arts and other training, research or educational works.

14) To open, found, establish, promote, set-up, run, maintain, assist, finance, support and / or aid or help in the setting up and / or maintaining and / or running hospitals, clinics, charitable dispensaries, maternity homes, child welfare centres, convalescent homes, sanatoriums, hostels, and other similar institutions, or centres for rendering or providing medical relief and / or aid to suffering humanity especially for the mentally retarded or for research centres, and institutions for promotion of research and education for medical science including surgery.

15) To open, found, establish, promote, set-up, run, maintain, assist, finance, support and / or aid or help in the setting up and / or maintaining and / or running by monetary gifts or otherwise centres, stadiums, boarding houses, librariés, reading rooms, gymnasium, other training and vocational institutes, playgrounds, auditoriums, community halls and parks for public use for sports and games and other social welfare works and or activities and also to provide meeting- room for socially useful activities and functions in India.

16) To publish, produce, release, distribute and market books, magazines, pamphlets, journals, periodicals, reports, lectures, and other reading materials, audio and or video cassettes or compact disks and also to deal in musical instruments in India for the spread and advancernent of education, literature and culture and obtain copyrights and patent rights and royalty for the same but not involving carrying on of an activity for profit.

17) To promote, organise, administer, establish, support and /or grant aid for, or assist and /or maintain all activities by whosoever carried on or wherever carried on in India in conformity with the objects of the trust and as are conducive to the well being and general welfare of the nation or are conducive for advancement of any object or objects of general public utility not involving any activity for profit.

18) To organise, start, run or assist any programme either by itself or by assisting or coördinating with other educational or other institutions for coaching, guidance and counseling, vocational training or training for preparation for any entrance or competitive tests for recruitment for jobs including All India and State Service examination or for admission to professional or other educational institutions or for employment.

19) To start, run, assist programmes for the scheduled Castes, scheduled Tribes, Backward classes, Women, Children, bonded labourers and other sections of the society for the promotion of legal awareness, legal assistance, training of paralegals, human rights, Civil rights, and other matters concerned with overall development of these sections of the society.

20) To run, organise workshops, personality development, leadership training programmes, seminars, counseling centres for the educated unemployed and the rural youth in co-ordination with other organisations.

21) To run computer training centres without profit motive.

22) To give loans at nil or subsidised rate of interest to students, women, widow, destitute, and other weaker sections.

23) To arrange, hold, and provide for or join in arranging, holding and providing for lectures, training programmes, exhibitions, meetings, classes, conferences, and other things reasonably necessary for the advancement of the objects of the society.


24) To establish, run, and operate websites or such other electronic or computer media as may be conducive or incidental to the objects of the trust.

25) To establish, manage, run and operate marriage-counseling centres.

B. OTHER OBJECTS (OBJECTS INCIDENTAL OR ANCILLIARY FOR THE ATTAINMENT OF THE MAIN OBJECTS)

- a) To accept donations, grants, presents, and other gifts in cash or in kind and to deal with the same for the purpose of the trust.
- b) To acquire movable and immovable properties by purchase, lease or otherwise and to construct buildings on the land thus purchased for the purpose of the trust.
- c) To invest the Trust Funds or deal with the same as the Trustees may deem fit, to carry on the objects of the trust effectively.
- d) To enter into any agreement with any Government authorities whether Central, State, Local, Municipal or otherwise in pursuance of the objects of the Trust to obtain from any such Govt. authority all rights, concessions, privileges, aid, grants, etc., that may deem conducive to the objects of the Trust.
- e) To work in coordination with any other Trust or Institution, having similar objects, aid, assist other agencies or to undertake any activity entrusted or delegated to it.
- f) To open and operate accounts of any description with any bank or banks for the trust.
- g) To apply for and get sanction and disbursement of credit facilities of any type – cash credit, overdraft, term loan, housing loan, loan on fixed deposit, etc., from banks, financial institutions and cooperative societies and to pledge, hypothecate, mortgage the properties of the trust, movable or immovable, to secure the loans raised.
- h) To pay the costs, charges, and other expenses, preliminary and incidental to the formation, establishment of the Trust.
- i) Generally to do all such other things as are incidental or conducive to the attainment of the above objects.

05. PROPERTY VESTED IN THE TRUSTEES:

The founder does hereby transfer a sum of Rs.1000/- (Rupees One Thousand Only) as aforesaid in favour of the trustees and unto the trustees hereof. The trustees shall hold the said fund and other properties that may be endowed or conferred on the said trust for the use and benefit of the trust.

The trustees shall invest the trust fund in such manner as prescribed under section 13(1)(d) read with Section 11(5) of the Income Tax Act and such other provisions as may be applicable from time to time.

06. EXECUTIVE COMMITTEE:-

The Executive Committee shall be the Supreme authority of the Trust. The Executive Committee shall make all policy decisions and provide expert guidance for the achievement of the objects and smooth running of the Trust.

The Executive Committee shall consist of two lifetime members:


- 1. Sri.K.Raju – Executive Chairman
- 2. Smt.R.Pappa -- Executive Co-Chairman

The above members are the founders of the trust and shall form the Executive Committee. They shall hold office till their lifetime. Any vacancy caused in the Executive Committee shall be filled up by the remaining Executive Committee member. If vacancy arises for both the seats at a time, the vacancies shall be filled up by already selected candidates from Sri.K.Raju's family or his successors.

The Executive Committee shall have the powers to appoint the Managing Trustee, Joint Managing Trustee and all other Board members of the Trust, with the guidance of the Managing Trustee. The Executive Committee may also delegate the powers of appointing the Trustees to the Managing Trustee. The Executive Committee shall have the powers to remove the Managing Trustee, Joint Managing Trustee or any other members of the Board of Trustees, without assigning any reasons, whatsoever.

The Executive Committee shall have the powers to call for anytime the details of the activities done by the Trust, accounts of the Trust, assets and liabilities position of the Trust, details of the office bearers of the trust and any other information, which the Committee may feel necessary for the smooth and effective running of the trust.

07. MANAGING TRUSTEE & JOINT MANAGING TRUSTEE:

Sri. R.Muthupandi, son of Sri. K.Raju, aged about 24 years, residing at 2/434, Sannasipatti, Vilampatti Post, SIVAKASI – 626 124, Tamilnadu shall be the first Managing Trustee of the Trust for a period of 3 years.

Sri R. Muthukrishnan, son of Sri. K.Raju, aged about 22 years, residing at 2/434, Sannasipatti, Vilampatti Post, SIVAKASI – 626 124, Tamilnadu shall be Joint Managing trustee of the trust for a period of 3 years.

The Managing Trustee and Joint Managing Trustee if he / she so desires resign his / her post by giving 3 months notice to the Executive Committee even before the expiry of the term of Trusteeship

The MANAGING TRUSTEE and JOINT MANAGING TRUSTEE shall be the executive head of the trust and shall be responsible for carrying out the routine management of affairs of the Trust.

The Managing Trustee and Joint Managing Trustee shall have the following powers. The Board of Trustees may delegate all or any of their powers to the Managing Trustee and Joint Managing Trustee in addition to the following:

- (a) To hold meetings of the Board of Trustees at least once in three months and convey the proceedings of the Board to the Executive Committee.
- (b) To appoint all necessary staff for the management of the Programmes of the Trust and to fix their remuneration and service conditions, subject to service rules prescribed by the Trustees.
- (c) To open and operate Bank account for the Trust which will be jointly operated by both Managing Trustee and Joint Managing Trustee.
- (d) To enforce, resist, allow, remit, set off or compromise or to refer to arbitration any claim by or against the Trust.
- (e) To institute and carry on or discontinue and to defend legal proceedings in relation to the Trust and for the Trust and for the said purpose or purposes to sign, execute, verify and file any complaint, written statement, application, claim or objection as may be necessary.
- (f) To appoint advocate, pleaders, or attorneys Chartered Accountants for any or all the purposes stated in the clause (d) and (e) thereof.
- (g) To demand, receive, take, transfer of and recover or allow on account of any money or moneys or property belonging to the Trust and to give effective receipts in respect of any money or property so received or allowed in account by or transferred or delivered to the trust.
- (h) To draw, accept, endorse, give, make or negotiate, cheques, bills, hundies, notes, guarantee or other security for any purpose aforesaid.

(i) To execute, do or conduct in or cause to be executed and done all such deeds, instrument and things in relation to the Trust and for the said purpose to sign, execute, endorse or transfer any deed or instrument or thing and to present the same for registration before any registering Authorities.

(j) To apply for and get sanction and disbursement of credit facilities of any type – cash credit, overdraft, term loan, housing loan, loan on fixed deposit, etc., from banks, financial institutions and cooperative societies and to pledge, hypothecate, mortgage the properties of the trust, movable or immovable, to secure the loans raised. The signatures of the Managing Trustee and Joint Managing Trustee shall be sufficient to bind the Trust in all the transactions, documentations, etc., between the Trust and the bank or financial institution as the case may be.

08. BOARD OF TRUSTEES :-

Sri. R.Muthupandi, son of Sri. K.Raju, aged about 24 years, residing at 2/434, Sannasipatti, Vilampatti Post, SIVAKASI – 626 124, Tamilnadu, the Managing Trustee of the Trust shall also be one of the Trustees for a period of 3 years..

Sri. R. Muthukrishnan, son of Sri. K.Raju, aged about 22 years, residing at 2/434, Sannasipatti, Vilampatti Post, SIVAKASI – 626 124, Tamilnadu, the Joint Managing Trustee of the Trust shall also be one of the Trustees for a period of 3 years.

Sri.R.Muthukumar son of Sri. K.Raju, aged about 20 years, residing at 2/434, Sannasipatti, Vilampatti Post, SIVAKASI – 626 124, Tamilnadu shall also be one of the Trustees for a period of 3 years..

The Board of Trustees shall ordinarily consist of not less than two and not more than five members including the Managing Trustee and Joint Managing Trustee appointed as in (7) above. The Managing Trustee and Joint Managing Trustee shall co-opt any new members to the Board of Trustees, as and when any vacancy arises. The trustees co-opted by the Managing Trustee and Joint Managing Trustee shall hold office for a period of three years. The Trustees may if he / she so desires resign his / her Trusteeship even before the expiry of the term of Trusteeship.

09. MEETINGS OF THE BOARD OF TRUSTEES :

(a) The Board shall hold meetings at least once in a quarter. The Board shall hold an Annual General Meeting once in a year, in addition to the regular Board Meetings, mainly for the purpose approving the audited Statement of Accounts and the Report of the Managing Trustee about the working of the Trust during the previous year.

(b) The Board meeting shall be convened by the Managing Trustee and Joint Managing Trustee by giving at least 7 days notice. The Managing Trustee and Joint Managing Trustee may delegate the powers of convening and conducting the Board Meeting to any other Trustee in their absence.

(c) The Board shall transact any business that may be specified in the Agenda or otherwise agreed to by the Board of Trustees.

(d) The Board shall appoint an Auditor at the Annual General Meeting to hold office till the conclusion of the next Annual General Meeting.

(e) The quorum of the meeting is $1/3^{\text{rd}}$ of its total number of Trustees, subject to a minimum of two Trustees.

(f) All major decisions shall be carried out by the Board.

(g) Any decision in writing signed by all the Trustees shall be binding on the Board as though it has been passed at a meeting of the board of trustees.

(h) The Board may invite others interested in the working of the Trust as special invitees to attend the meeting of the Board but they shall not be entitled to vote thereat.

(i) The Board may, by resolution, extend the activities of the Trust and objects of the Trust.

(j) The Trustees may frame rules and regulations as to the duties and responsibilities of each Trustee, to appoint sub-committees, mode of conducting any other matters connected with the administration of the Trust and its management.

(k) The Trustees may maintain an Advisory Committee, whose expert advice and services may be utilised in furtherance of the objects of the Trust.

10. DUTIES AND POWERS OF TRUSTEES:

(a) The trustees may, out of the corpus of the trust, spend money or part thereof for capital or revenue expenditure as may be decided by the trustees.

(b) The Trust Fund shall consist of the Trust money hereby created and all donations and income received and such future contributions that may be made to the trust.

(c) Subject as aforesaid the Trustees shall, from time to time make and alter the regulations with regard to the conduct of the business of the Trust and all matters in respect of which any power and duty is hereby vested in them as they may think proper.

(d) The Trustees shall not receive any remuneration for administration of the Trust. Any out of pocket expenses incurred by any Trustee for the Trust can be reimbursed from the Trust Funds.

(e) The Trustees shall frame rules for the administration of the Trust and their management and shall have power to modify them from time to time, as the exigencies of the situation require.

(f) The Trust may receive donations of money and or properties when received shall be at the absolute disposal of the Trust.

(g) The Trustees shall invest the properties and money of the Trust in such manner as prescribed under sec.13 (1)(d) read with sec.11 (5) of the Income Tax Act.1961 and other statutory laws.

(h) The Board may, by resolution, extend the activities of the Trust or undertake any activity in furtherance of the main object of the Trust.

(i) The Trustees may frame rules and regulations as to the duties and responsibilities of each Trustee, to appoint sub-committee, mode of conducting any other matter connected with the administration of the Trust and its management.

(j) The Trustees may maintain a set of advisors for the purpose of utilising their services in furtherance of the object of the Trust.

11. CHAIRPERSON:

The Board Meeting shall be presided over by the Managing Trustee and in his absence, the Trustees present may elect a chairperson among themselves to preside over the meeting. The Chairperson will have the casting vote.

12. ACCOUNTS AND AUDIT

Proper books of accounts shall be maintained at the Registered office of the Trust and the accounts shall be closed every year by 31st March.

The accounts of the Trust shall be annually audited by a qualified Chartered Accountant appointed by the Board of Trustees and the audited statement of accounts shall be placed before the Board for its approval within six months of the close of the financial year. On approval by the Board, the accounts shall be placed before the Executive Committee.


13. BANK ACCOUNTS:

Bank account shall be opened in the name of the Trust and the same shall be operated jointly by the Managing Trustee and Joint Managing Trustee..

14. CUSTODY OF DOCUMENTS:

The Managing Trustee or his nominee or any other Trustee, authorised by the Board of Trustees shall have the custody of all the documents, deeds of title relating to the Trust properties movable or immovable and investments made and the books of account, audit reports and other records relating to the Trust and shall be responsible for the preservation of the same.

15. AMENDMENT TO THE TRUST DEED:

Though this trust shall be irrevocable, the Board may amend the clauses relating to trustees and management of the Trust at a duly convened meeting of the Board by a special resolution passed by a 3/4th majority of the members present. Any fraction while arriving 3/4th shall be reckoned as one. Any amendment to the Trust Deed shall be carried out only with the approval of the Executive Committee of the Trust and Commissioner of Income Tax / Director of Income Tax (Exemptions) having jurisdiction over the Trust.

However, the amendments to the Trust Deed effected as above shall not alter the basic character / objects of the Trust and no such amendments which may prove to be repugnant to the provisions of Section 2(15), 11 and 13 and 80G of the Income Tax Act shall be made.

16. ADVISORY BODY:

The Trustees, if decided in the meeting of the Board of Trustees, shall maintain an Advisory Body, consisting of eminent personalities for the purpose of getting expert advice on important matters in furtherance of the object of the Trust.

17. IRREVOCABILITY:

It is declared that the Trust is irrevocable. If the Trust fails for any reason, in the opinion of the Trustees, the net assets of the Trust both movable and immovable shall be handed over to any other Trust having the same or similar objects as decided by the majority of the Trustees after getting the approval of the Executive Committee. The Executive Committee shall be the final authority to make any decision in this context.

18. GENERAL

- a) The Trust is Irrevocable.
- b) The activities would be Purely charitable nature not motivated for profit.
- c) The funds of the institution would be utilized only towards the objects and no portion of it would be distributed in any manner to the trustees or persons defined in sec.13 (1) (c) of the Income tax Act.
- d) The benefit of objects would be available to the general public irrespective of caste, creed, religion or sex.
- e) The Trust shall utilise the income and funds of the trust solely towards the objects of the Trust herein contained and no portion of it shall be utilised for payment to the Trustees by way of profit, interest, dividend or otherwise.

h) There are no movable or immovable properties belonging to the Trust.


